It's time to start thinking about K&K Insurance coverage for the 2010/2011 period. The good news, especially in this continuing time of belt tightening, is that the rates have again remained the same for the 3rd consecutive year. The premium is \$8.24 per ACTIVE member. If you have 100 members but only 30 actively attend meetings, you pay only for 30 ACTIVE members. This insurance will cover your Club for NON-MOVING events such as meetings, social events and local Car Shows. This coverage means your Club will have \$2,000,000 Commercial General Liability, \$300,000 Damage Premises Rented and \$100,000 E&O (Errors and Omissions) per occurrence.

The K&K Insurance renewal date is 3/1/10 and is good through 2/28/11. The ZCCA has already renewed the policy to cover you, if you paid for non-moving Insurance last year, but you still must send your insurance premium money to me within 30 days. Be aware that your previously paid premium/coverage is only good until 2/28/10 and there is NO prorated premium based on when you eventually send your check /money order. New Clubs must pay their premiums for next year in order to have coverage. They are not covered as part of the early renewal by the ZCCA. All checks/money orders should be made payable to ZCCA in U.S. dollars only.

MOVING events are an additional premium charge:

1. Autocross/Gymkhana PER EACH EVENT (running contiguous days) is \$282.00.
2. Rally/Poker Run/Toy Run, National or Regional Car Show, Car Wash, Guided Tours are priced as follows:
Attendance 1 - 250 = \$159.00, Attendance 251-500 = \$196.00, Attendance 501-1500 = \$332.00,
Attendance 1501-3000 = \$412.00 and Attendance over 3000 = \$519.00.

These premium charges are also PER EACH EVENT (running contiguous days) for each attendance category.

If you are submitting premiums for multiple and different standard events, as listed above, please complete a K&K Form B with dates, places and details for EACH event being insured. Exception - If your Club has more than one occurrence of the SAME event per year, only one Form B needs to be completed but it must have the separate dates for each event. If this information is not submitted, it will delay your insurance coverage until it is received.

If you need to purchase additional non-standard insurance coverage, such as racetrack insurance or other events not specifically listed above, you must contact the ZCCA Treasurer directly who will assist in getting a quote/coverage. You are still responsible for completing a Form B for each event to obtain a quote.
